



## Declaration under Section 19 Local Nuisance and Litter Control Act 2016

Pursuant to Section 19 of the Local Nuisance and Litter Control Act 2016 (the Act) the City of Salisbury (or delegate) can exempt a person from the application of Section 18- Causing a local nuisance, in respect of a specified activity if the Council for the area (or delegate) in which the activity is to be carried on declares, by notice in writing, in accordance with this the Act section, that the person is so exempt.

This declaration has been considered and issued to the **Applicant** for the purposes of the following specified activity:

- concerts or events;
- activities using amplified sound.

This declaration can be unconditional or subject to conditions, including (but not limited to) conditions relating to—

- (a) the permitted times or periods of time for carrying on the activity; or
- (b) the manner of carrying on the activity.

<b>Conditions</b>
Any music played at the event must only be played via the in house controlled sound system installed on the Premises, which must, when in operation, be set to a level that does not give rise to a local nuisance under the Act (as determined by an authorised officer acting reasonably),
Any amplified live music must be monitored for impacts on the external environment.
Whilst amplified music is being played - ensure all side exit doors are kept shut at all times whilst the hall is in use to reduce noise impacts.
Ensure the front entrance doors of the Premises are kept shut at all times during the event whilst amplified music is being played, other than when patrons are entering or leaving
Ensure responsible persons/ security staff at the event are monitoring behaviour in the car parking area preventing any antisocial behaviour, alcohol consumption and music being played outside the venue
Ensure responsible persons/ security staff at the event are monitoring and controlling vehicle movements to limit and reduce vehicle noise during the event and as people leave the premises;
Ensure there are sufficient number of responsible persons/ security staff engaged for the event to suitably prevent noise nuisance and manage crowd behaviours and traffic movements.
The recommended number of responsible persons/security staff to be engaged are; <ul style="list-style-type: none"> <li>• a minimum of 4 responsible persons/security staff required to manage all 4 sides of the building and carparks</li> <li>• additional persons stationed at all exit/entrance doors, and</li> <li>• pending traffic management advice additional persons to manage entry and exit from Salisbury Highway</li> </ul>
Manage internal carparking and traffic flows in a manner that facilitates one-way travel in and out to provide a safe environment for pedestrian's and for traffic movements. <i>(please consult traffic management consultants for formal advice)</i>
Consult with Department of Infrastructure and Transport for any requirements for Traffic Management plans to manage traffic entry and exit from the site as Salisbury Highway is a State Road and if Traffic Management Plan is required forward a copy to City of Salisbury
