The proposed strategy for minimising, managing and monitoring the effects of the local nuisance on potentially affected persons;

To minimise potential disturbances from early morning concrete pours, we propose the following strategies:

## Minimising Impact on Residents

Provide residents with a detailed schedule of upcoming early morning pours, including expected dates and durations, so they can anticipate and prepare for any temporary disruptions. Notice Board on Front Fence as discussed.

Ensure that any required lighting is directed away from nearby residences to reduce light pollution.

## **Management of Onsite Activities**

Limit loud machinery use and restrict activities to only essential tasks during early morning hours.

Organise and stage equipment and materials the day before to minimize setup time in the morning, reducing the need for additional noise during early hours.

Conduct a pre-pour briefing with all site personnel to reinforce quiet work practices, including handling equipment and materials with care to avoid unnecessary noise.

Avoid using loudspeakers or radios on site and communicate instructions to workers directly to keep noise levels low.

Schedule concrete truck arrivals in staggered intervals to reduce traffic noise and prevent vehicles from idling near residential areas.

## **Monitoring and Communication**

Notify potentially affected residents well in advance, explaining the timing, duration, and purpose of early morning pours.

Notice Board on front fence, main entrance.

A letterbox drop off will be completed ahead of pour day to notify neighbouring properties of the disruption.

These strategies aim to balance project needs with community comfort, reducing local nuisances while allowing essential project activities to proceed efficiently.

# Re: Notification of Potential Nuisance Resulting from Construction Works at: 29-39 WRIGHT ROAD, WALKLEY HEIGHTS

The purpose of this letter is to inform you that Sarah Constructions will be undertaking construction works in the form of concrete pouring and finishing at 29-39 Wright Road Walkley Heights.

This activity may result in local nuisances in the form of noise and light emissions being generated through the construction process that includes the delivery, pouring and finishing of concrete, support vehicle movements and lighting.

The request for additional early starts has been made due to the need to complete the significant foundations on the Cultural Institutions Storage Facility. This major development is a 2 storey building with a foot print of approximate 5800 square metres and supporting infrastructure. It is designed to store and preserve cultural material that has been identified by all arts collecting institution, with the aim of improving storage facilities and opportunities to better display and use art and culture collections for improved tourism and educational/research outcomes.

As a result of the size of the development the construction of this facility requires significant works including large, staged concrete pours for the foundations.

The early morning concrete pour is an essential part of the works for the Raft Slab, Pads, and Strips, which are critical components of the project's foundation. The main reasons for the early start include:

**Structural Integrity:** The scale of this pour requires a continuous supply of concrete and sufficient time for it to properly cure. The early start is vital to ensure the quality and safety of the structure.

**Weather Conditions:** The cooler temperatures in the early hours are required for concrete work, helping to ensure the best possible finish and structural integrity of the works.

Concrete Supply and Feasibility: The early start is necessary to ensure a steady and uninterrupted supply of concrete, which is crucial for maintaining the quality and consistency of the pour.
