

# City of Salisbury, Salisbury Aquatic Centre, Colouring-in Competition 20 June to 22 July, 2024 Terms and Conditions:

## 1. Method of Entry

- Entry Period: Entries open at 9am on Thursday, 20 June 2024, and close at 5pm on Monday, 22nd July 2024.
- **Entry Form**: Entries must be drawn onto the official Entry Form entries on separate pieces of paper will not be accepted.
- **Number of Entries Permitted**: Only one entry is permitted per person. Maximum of one prize will be awarded per person
- **Submission Details**: Entries must include the child's full name, address, age, and a signature from a parent/guardian.
- **Original Work**: All entries must be the original work of the entrant. Use of artificial intelligence (AI) or AI-generated content in the creation of entries is strictly prohibited.

## 2. Eligibility

### Who Can Enter

- Residency: Entry is open to individuals who are residents of the City of Salisbury.
- Age: Entrants must be between five (5) and sixteen (16) years of age as of the entry date.
- Parental/Guardian Consent:
  - o **Requirement**: All entrants must provide parental or guardian consent.
  - Submission: This consent must be confirmed by a parent or guardian's signature on Parental/Guardian Consent Form.
  - o **Acknowledgment**: This consent confirms that the parent/guardian has read and understood the Terms and Conditions and agrees to the entrant's participation.
- Ineligibility:
  - o Minors of employees or Elected Members of the City of Salisbury are not eligible to enter.

## 3. Method of Lodgement

- Submission Methods: Entries must be lodged either:
  - o In person or posted to the City of Salisbury, 34 Church Street, Salisbury SA 5108, or
  - Emailed as a high-resolution JPG to communications@salisbury.sa.gov.au by 5pm on Friday, 22nd July 2024.
- Late Entries: No late entries will be accepted. The Promoter accepts no responsibility for any late, lost misdirected, delayed, ineligible, incomplete or corrupted entries or delays in the delivery of entries due to technical disruptions, network congestion or for any other reason.

**Family Pass Definition**: A family pass consists of two adults and three children or one adult and four children. Children under two are free of charge and not included in a family pass. One child under five must be accompanied by one adult, and two adults must accompany two children under five.

Notification: Winners will be notified by email and telephone on Thursday, 25<sup>th</sup>July 2024.

## 7. Copyright and Usage

- Usage: The winning entrant's Work will be displayed at the City of Salisbury's Libraries.
- **Credit**: The entrant's first name and age will be credited on the Work.
- **Copyright**: The entrant, or their parent/guardian, retains ownership of any intellectual property rights, including copyright, in materials submitted to the Promoter for the competition (Work). By submitting an entry, the entrant, or their parent/guardian, grants the Promoter a non-exclusive, irrevocable license to use the Work for promotion purposes. This includes modifying, adapting, and publishing the Work in various formats, without entitlement to fees or royalties. The entrant, or their parent/guardian, consents to minor alterations to the Work for print or display purposes.

## 8. Parental/Guardian Consent

### • Requirement:

- o **Validity**: Entries without a valid consent form will be disqualified.
