1. BACKGROUND

1.1 At its meeting on 16 December 2024, Council resolved:

'Administration provide information reports to the Intercultural Strategy and Partnerships Sub Committee commencing February 2025, providing an update on discussions and outcomes from the quarterly Salisbury Intercultural Strategic Alliance and Salisbury Intercultural Community Alliance meetings.'

(Resolution Number 0812/2024)

1.2 This report provides a summary of discussions at SICA and SISA meetings from the final quarter of 2024.

2. EXTERNAL CONSULTATION / COMMUNICATION

- 2.1 Salisbury Intercultural Community Alliance (SICA)
- 2.2 Salisbury Intercultural Strategic Alliance (SISA)

3. DISCUSSION

- 3.1 SICA met on 26 November 2024 at the Salisbury Community Hub.
- 3.2 Guest speaker, Community Programs Coordinator, attended to discuss intersections of interculturalism and youth at the request of SICA members. Topics discussed included the booking system of Twelve25 SpacetoCo, Learning to Drive program, Youth Action Plan 2027 and the end of year Australian Refugee Association celebration at Twelve25.
- 3.3 SICA members suggested a 'clothes swap' or 'clothes bins' being located at Council buildings. SICA members asked about the Council's response to youth homelessness and a SICA member suggested that staff create anonymous ways for youth to provide feedback (e.g. an advice box).
- 3.4 Guest speaker, Green Adelaide staff, attended to discuss with SICA ways that culturally and linguistically diverse communities connect with nature. Green Adelaide invited SICA members to advise them how they can assist in facilitating connection to green open spaces.
- 3.5 SICA members expressed interest in Green Adelaide developing infographics with Kaurna language and Aboriginal and Torres Strait Island cultural connection to nature, for example Kaurna language names for local birds and wildlife.
- 3.6 SICA members discussed with staff ideas for updating the SICA flyer and ways to attract new members to SICA. SICA provided some edits to the existing flyer and suggested more age diversity in the photographs.
- 3.7 SISA met on 11 December 204 at the Salisbury Community Hub.
- 3.8 Guest speaker, Senior Business Development Consultant from Skilled Business and Migration, State Government, attended to discuss the intercultural priority area of employment. An update on the State's nomination of 3,800 skilled migrants from occupations including trades and construction, defence, space and cyber security, technology, health and medical, life science and social and welfare was provided. Currently there are 40,000 expressions of interest for the 3,800 available positions.
- 3.9 Department staff offered to engage with local employers about the scheme and discussed the recruitment and migration scheme. SISA members and Council Administration had the opportunity to ask questions on behalf of SICA members and the culturally and linguistically diverse community.
- 3.10 Staff provided SISA with an update on the Diversitours project noting that recruitment for Diversitours tour guides is complete and they are now in the tour guide training stage.
- 3.11 SISA membership was discussed with SISA members invited to suggest other sector leaders to invite.

- 3.12 SISA members also provided updates from their respective organisations including:
 - 3.12.1 AMES Australia advised on current migrant arrivals to the City of Salisbury
 - 3.12.2 Australian Refugee Association provided updates on their successful programs 'Play our Way; and 'ARA Drive' and Twelve25 ARA collaborative end of year party.
 - 3.12.3 Council staff provided updates from the Council of Europe Intercultural Cities meeting and the World Health Organisation Age Friendly Conference.

4. CONCLUSION

4.1 The Salisbury Intercultural Community Alliance and the Salisbury Intercultural Strategic Alliance meetings provided valuable opportunities for members to discuss with each other and with Administration the current intercultural priorities and support implementation of the Intercultural Strategic Plan.
